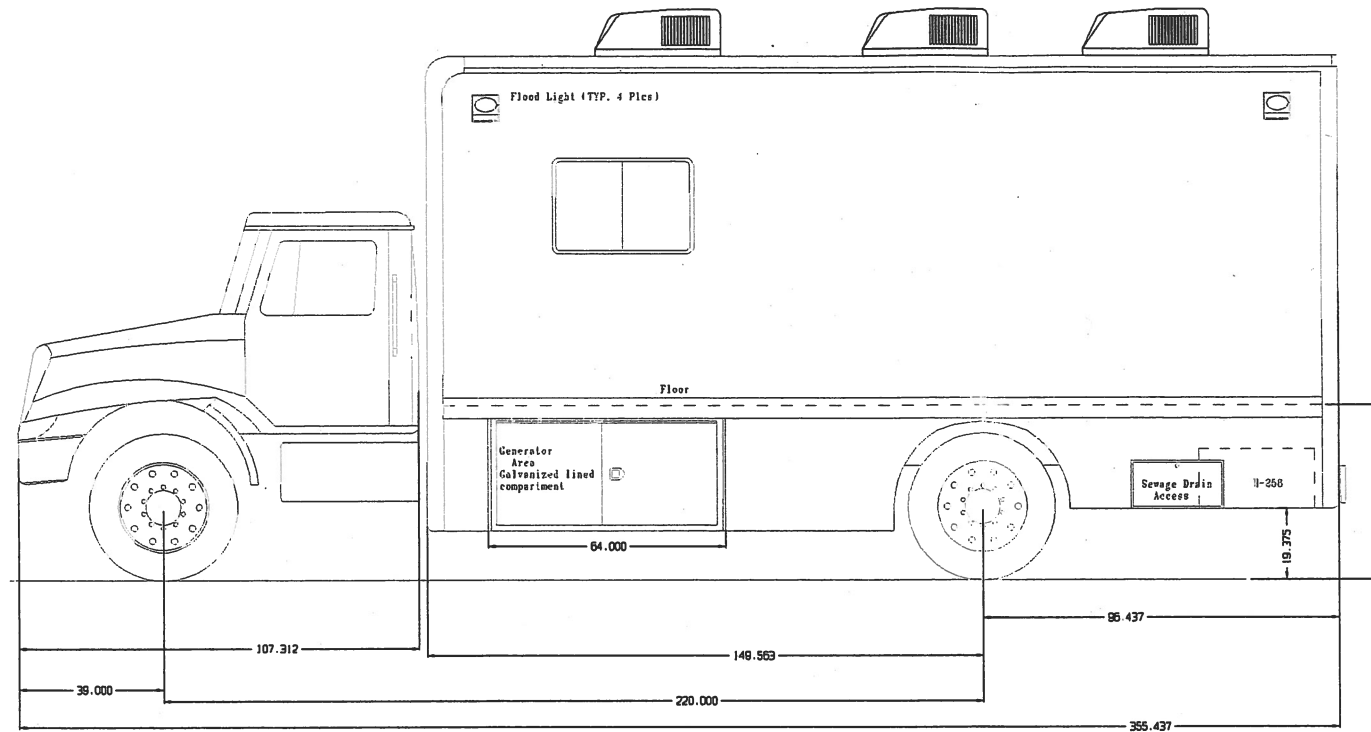
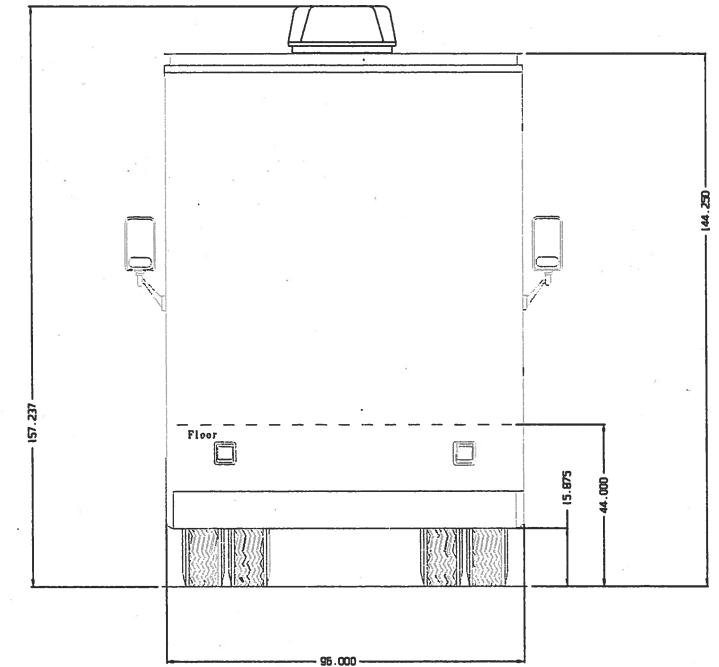
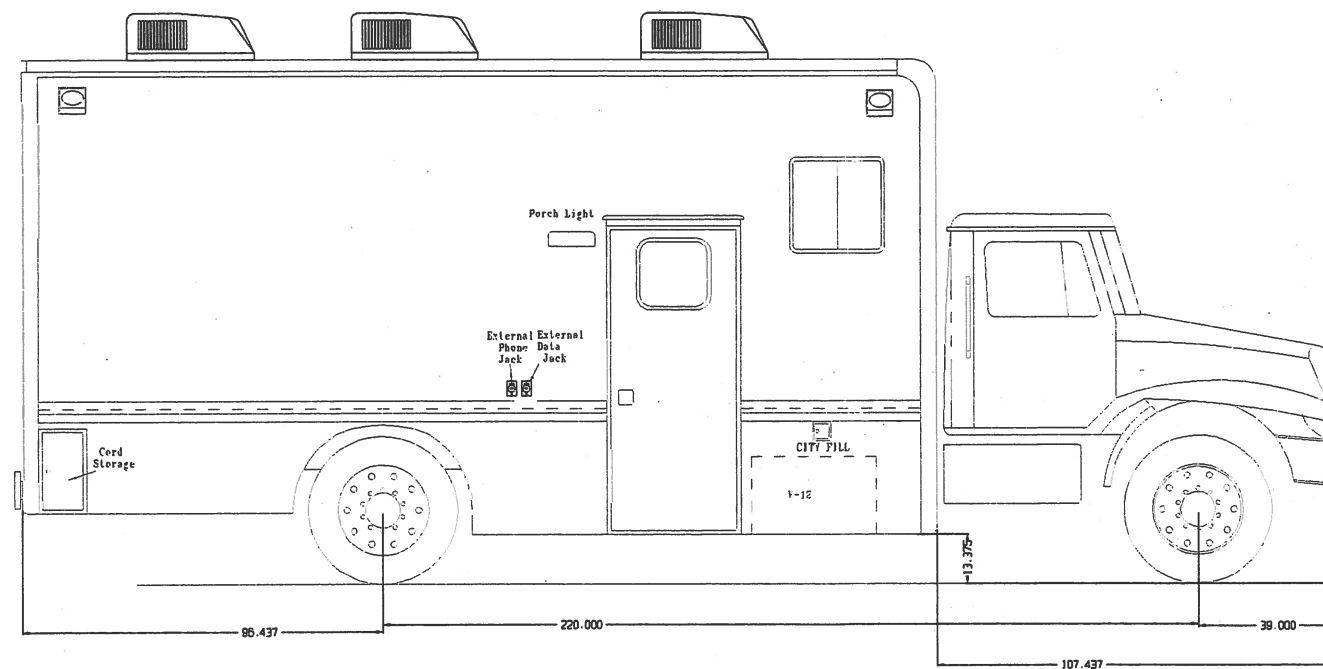




Driver's Side

Passenger's Side

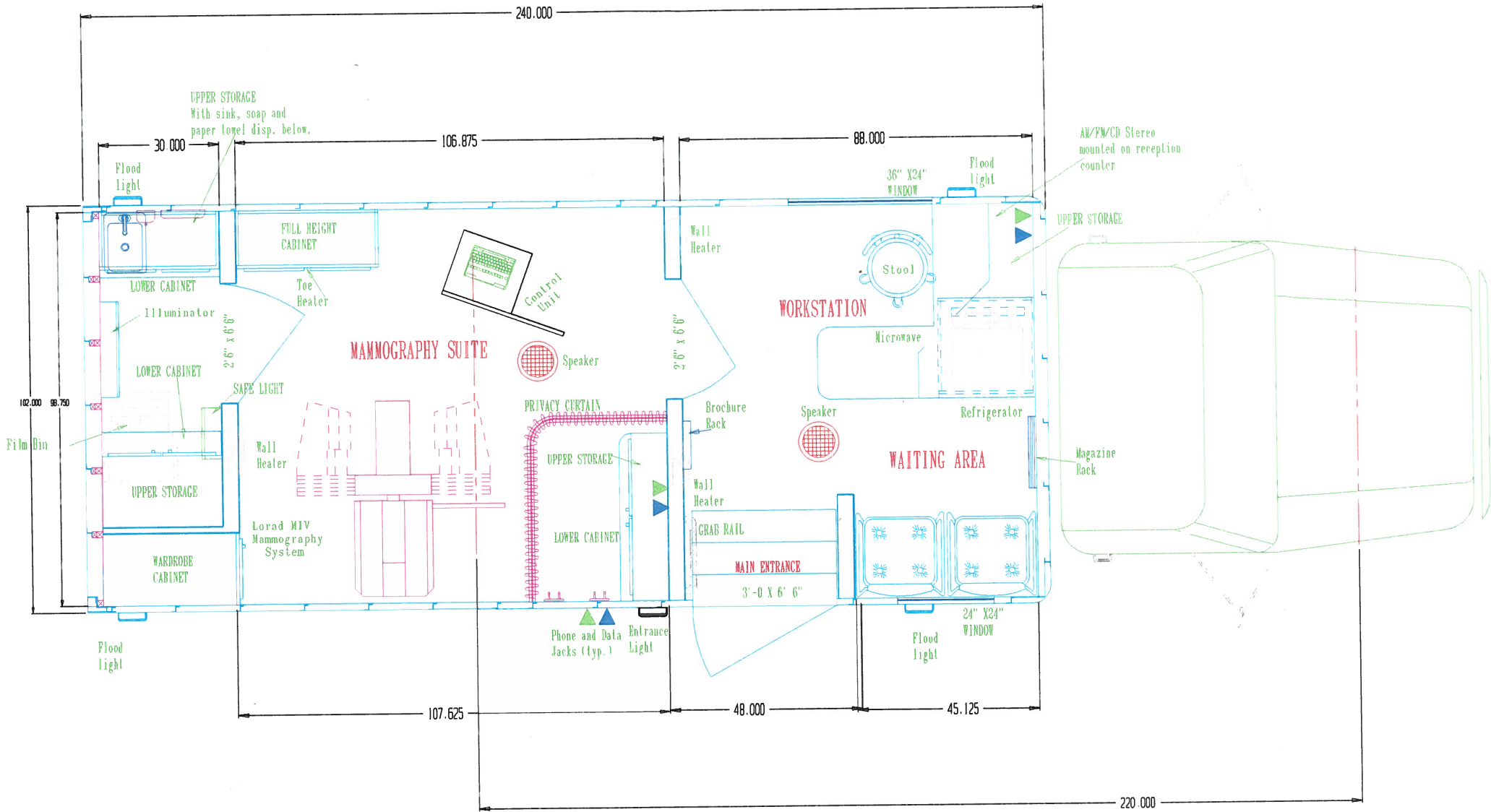
